## **Opening and Devotion**

The meeting opened in prayer by John Bradshaw at 6:35 pm. John Bradshaw gave the devotional.

#### **Business**

Meeting Minutes for the November 12, 2024 Vestry Meeting were reviewed.

*Motion:* John Bradshaw made a motion to accept the Minutes as presented. Sonia McGrath seconded the motion, and the motion passed.

The Treasurer's report (prepared by Treasurer Scott McLemore and included in the vestry packet) was presented by Greg Bethke.

*Motion:* Brandon Campbell made a motion to accept the Treasurer's report. Fred Steinkamp seconded the motion, and the motion passed.

Greg Bethke reviewed the Capital Campaign Report (included in the vestry packet). A draw on the construction loan was made in December 2024, with loan repayment for 2025 potentially covered by incoming pledges. Greg proposed using the ERC tax credit to cover loan repayment in 2026. For 2027, loan repayment will need to be funded through the general operating budget. Greg also proposed that in 2025 we begin to set aside money for the 2027 loan payments.

Greg discussed the preliminary budget that came out of the finance committee. The final budget will be approved at the January 2025 meeting. The next budget meeting will be held on Monday, January 13, 2025 at 5:30pm – all are invited to attend.

**Motion:** John Bradshaw made a motion to adopt a continuing resolution to maintain the December 2024 budget levels into January 2025, pending the approval of the 2025 budget later in January 2025. Brandon Campbell seconded the motion, and the motion passed.

**Rector's Report** – Fr. Ralph presented the Rector's report. See report in APPENDIX for details. The VPOD schedule was handed out and discussed. The January vestry meeting has been moved to January 18<sup>th</sup> at noon. This is right after the vestry retreat. The naming of the old green room and the parlor were discussed. The name discussed for the old green room is the Quiet Room and the parlor is the Rector's Study.

*Sr. Warden's Report* – Rick Lane presented the Sr. Warden's report (included in the vestry packet).

The vestry went into executive session at 7:52pm. Executive session ended at approximately 8:20pm.
